NZBS Support During Planned Industrial Action by APEX Members between Friday 27th December 2019 at 0001 to Friday 27th December 2019 at 23:59

DHB: Information Sheet

This document outlines the support that NZBS will aim to provide to the DHB during the period of industrial action.

The plan is based upon NZBS' current understanding that the industrial action will affect a number of our services and laboratories, but that we have been able to mitigate the impact on most services through internal staff management. At present we anticipate that we will be able to offer a normal service to most DHBs, with the exception of Canterbury DHB where discussions are ongoing. Those DHBs with blood banks not run by NZBS may be impacted by local factors. Please inform us if there are significant challenges to such services that may impact upon patient safety or our usual joint working.

1. Access to blood components and blood products

NZBS will continue to provide blood products on request during the period of industrial action. We anticipate that normal blood bank services will be maintained except within Christchurch Blood Bank where additional contingency planning is required. The procedure for requests for supply of blood components and products from NZBS Hub sites remains unchanged in all other DHBs.

2. Access to NZBS red cell reference services

NZBS' ability to provide red cell reference services will be maintained as usual during the period of industrial action.

3. Access to NZBS National Tissue Typing laboratories

A full tissue typing service will be provided during the period of industrial action. Normal systems should be followed.

4. Access to NZBS Medical Advice

NZBS will continue to provide 24-hour access to specialist clinical advice. During the period of industrial action.
